



## “Save & Play” Official Rules – Youth Savings Month 2025

1. **No purchase is necessary to enter or win.**
2. **Eligibility for Promotion:** All Meritus Credit Union ("Credit Union") members ages 17 or younger in good standing and a U.S. resident.
3. **Promotion Period:** Begins Tuesday, April 1, 2025 at 12:00 am (CT) and ends Wednesday, April 30, 2025 at 11:59 pm (CT), and applies to new Share Savings accounts opened for youth ages 0-17 at Meritus Credit Union during the promotion period, completed form submissions by current youth members or fully completed drawing “manual entry” slips.
4. **To Enter: Current members ages 0-17:** Scan the QR code on the Youth Savings Month member-only postcard, Submit a complete official contest entry form at [https://share.hsforms.com/1dpek0\\_8cRqKdlMp66zDKYg43h27](https://share.hsforms.com/1dpek0_8cRqKdlMp66zDKYg43h27) or completely fill out a drawing “manual entry slip.” Limit one entry per eligible member.  
**To Enter: New members ages 0-17:** Visit [merituscu.net](http://merituscu.net) or a Meritus Credit Union branch and open a new Share Savings account for youth ages 0-17; or completely fill out a drawing “manual entry” slip. Limit one entry per person.
5. All other entries (“manual entry”) will be entered in the drawing to win upon receipt of a written entry on a 3 x 5 piece of paper setting forth the child’s name, account number (if applicable), address, and telephone number and mail in an envelope to Meritus Credit Union, Youth Month 2025 Prize Drawing, 515 Guilbeau Road, Lafayette, LA, 70506. Entries must be postmarked no later than Tuesday, April 22, 2025. One entry per envelope for entries that are not automatic; no photocopied or mechanically reproduced entries accepted. One manual entry per person during the promotion period. Entries become the property of Meritus Credit Union and will not be returned. The Credit Union is not responsible for and cannot be held liable for lost, late, misdelivered, illegible, incomplete, postage-due entries or technical errors including failure of email, online or social media entries to reach Credit Union.
6. **Prizes:** Prize drawing will be held no later than Friday, May 9, 2025. A total of one (1) entry will be randomly selected from all qualified entries. The winning entry will be awarded the following prizes: one (1) \$100 LEGO gift card, one (1) \$100 SURGE Entertainment gift card, and one (1) transaction of \$100 added into the winner’s savings account. Winner may not exchange prize for another. Winner need not be present to win. No entrant may win more than one (1) prize, regardless of the number of entries submitted. Only winner of the drawing (or their parent or legal guardian) will be notified by phone. The Credit Union is not responsible for and shall not be liable for unsuccessful efforts to notify winner(s). If a selected winner cannot be contacted by phone provided on the entry form within 14 days of drawing, prize may be awarded to another randomly selected winner.
7. **Entrant Agreement:** Participation in drawing constitutes full and unconditional agreement of legal parent or guardian to, and acceptance of, these Official Rules as noted by legal parent or guardian’s signature to open youth savings account. Prize(s) will be awarded only if entrants comply with these Official Rules.
8. **Eligibility Exceptions and General Terms:** Employees of the Credit Union, members of the Board of Directors and volunteer officials, and their immediate family members are ineligible. Sweepstakes void where prohibited by law. All federal, state and local laws and regulations apply. No cash or other consideration will be paid, and winners are responsible for any applicable taxes or other expenses related to any prize awarded.
